That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 16th day of January, 1962, I found the Quarter corner of Sections, 25, 26

which was evidenced by an iron post 3 feet long, 1 inch dia. with brass cap marked:

From which bears:-

Poplar 5" S36¹/₂°W 25 lks. or 16.50' (now a 11" aspen S36°W 16.50' S26 S25
 With blaze facing corner.) 1933

Poplar 4" N53°E 30 lks or 19.8' (not found.)

The iron post and bearing trees were st. by G.L.O. resurvey of 1933.
