Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 26th day of September, 1962, I found the Center West 1/16 corner of Section 25 which was evidenced by G.L.O. survey of 1933

a set iron post 3 feet by 1 inch diameter with brass cap marked: W 1/16
Maple 10 inch N38½°E 54 lks. or 35.64 feet - Now 11 inch Maple S 25
stub N38°E 35.64 feet - Scribe decayed. 1933Maple 9 inch S73½°E 51 lks. or 33.66 feet - Now 11 inch Maple S74°E 33.66 feet -
Scribe partly evergrown.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch inside diameter 5 foot long galvanized wrought iron pipe filled with concrete and capped with a 3 inch bronze tablet stamped:
