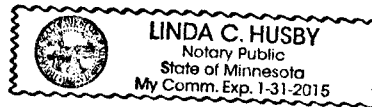

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minn., and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 362B.

I further depose and say that on the 29th day of January, 1962, I found the Center South 1/16 corner of Section 25which was evidenced by an iron post 3 feet long 1 inch diameter with brass cap marked Yellow Birch 14 inch S63°E 55 lks or 36.30 feet (Now a 19 inch dead Birch S63°E 36.3 feet scribed S1/16 S25B.T.)
Spruce 10 inch N66°W 36 lks or 23.76 feet (Now a decayed wind fall N66°W 23.76 feet)

The iron post and bearing trees were set by G.L.O. Resurvey of 1933.

Copy of the survey notes are on file in the State Capitol, St. Paul, Minn.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new marker set, used G.L.O. brass cap as corner.

Maple 7 inch S15°E 40.3 feet marked S25B.T.
