



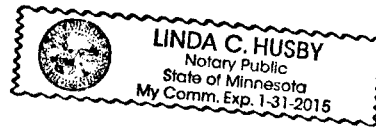

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 3rd day of April, 1964,
I found the section corner of Sections 34-35
which was evidenced by a monument set by G.L.O. resurvey of 1930 which is a 1" diameter iron post with brass cap stamped:

Birch 18" N.70°E. 42 links (27.7')(now a dead birch 19" at record bearing and distance with scribe partially visible.
