Statement of Evidence

North quarter corner, Section 4, Township 135 North, Range 31 West, 5th Principal Meridian, Cass County, Minnesota

1858 – Original U.S. Government Survey establishing this corner was performed. A wood post was set marking its location from which the following witnesses were established:

9" Bl. Ash S 85° E 9 links 9" W. Birch NORTH 7 links

1912 – John Curo in County Survey Record Book B, pages 12-28 set tamarack post proportionally and later set a 2 ½ x48" capped galvanized iron pipe in concrete. Established the following witnesses:

Pine stump S 76°28' W 2.05 feet Stump N 29°28' E 34.60 feet

1912 - Township road order indicates corner established

2014 – Patrick Trottier, PLS 41002, found no evidence of corner. Position was considered lost and established by single proportion method between NE and NW corners of said section 4. Set 1/2" x 48" iron pipe with plastic cap stamped "RLS 41002" in swamp. No viable ties were available to be set.
