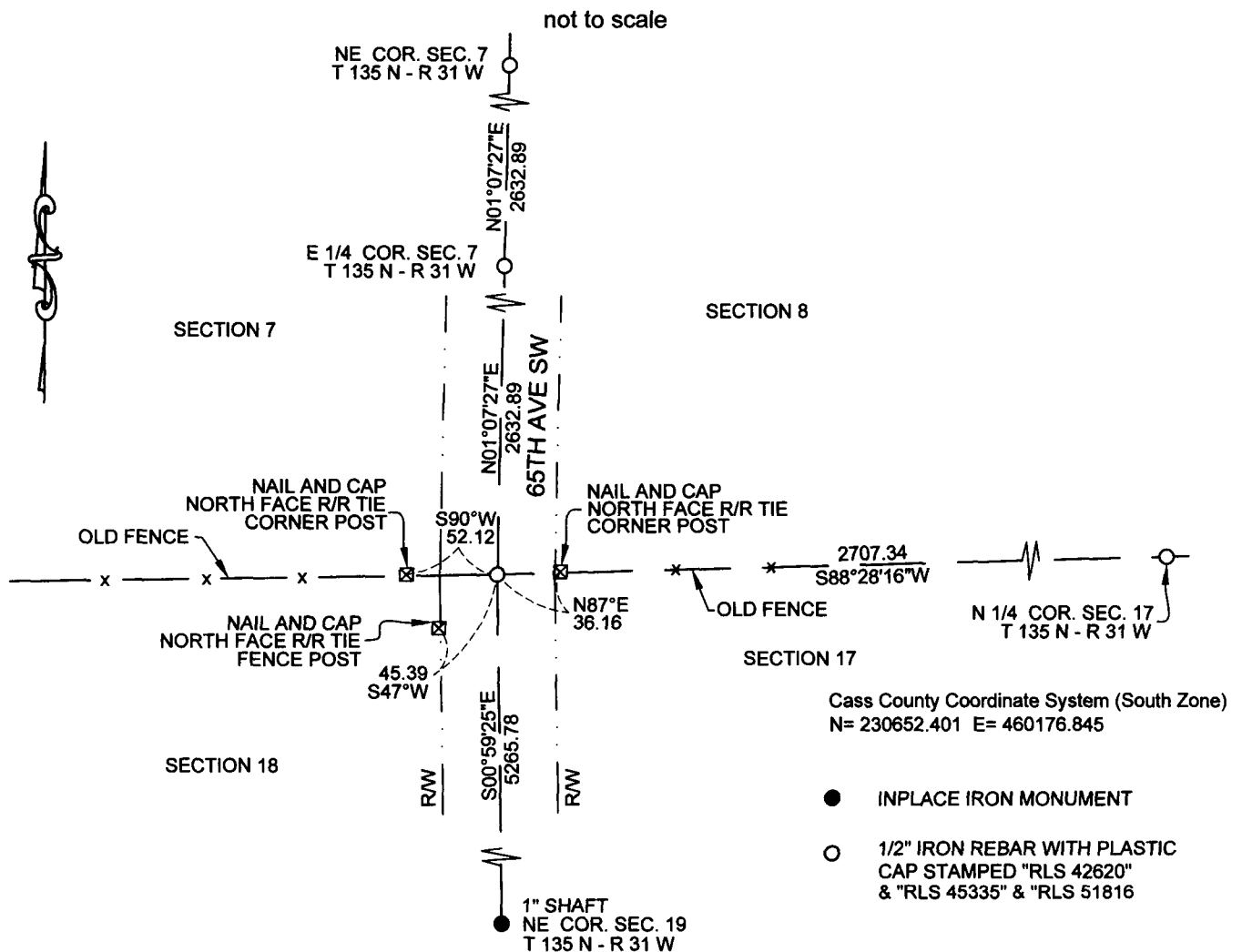

CERTIFICATE OF LOCATION OF GOVERNMENT CORNER


Northeast Corner of Section 18, Township 135 North, Range 31 West, Cass County, Minnesota.

On February 8th, 2016 a 1/2"x18" iron rebar with a plastic cap stamped RLS 42620, RLS 45335, RLS 51816 was set at this location 0.3' below the roads surface.

STATEMENT OF EVIDENCE

Northeast Corner of Section 18, Township 135 North, Range 31 West, 5th Principal Meridian.

Aug. 1870 Richard Cronk, General Land Office (GLO) Deputy Surveyor, in the notes of the subdivision of Township 135 North, Range 31 West, set a post for the original corner and referenced it as follows:

8" Spruce	N17°E	30 links (19.80 feet)
7" Spruce	S73°E	45 links (29.70 feet)
10" Spruce	S23°30'W	51 links (33.66 feet)
6" Balsam	N22°W	34 links (22.44 feet)

The above record is on file with the Minnesota Historical Society in St. Paul, Minnesota, copies are filed with the Cass County Highway Department, Surveyor's Office (CCHD/SO).

Jan. 18 2016 Nyberg Surveying obtained the above ties for the section corner information from the CCHD/SO website.

Jan.20 2016 Jeff Reed, Senior Survey Technician with Nyberg Surveying searched the area, no evidence of the original corner or bearing trees existed.

Feb. 8th 2016 Jeff Reed, Senior Survey Technician with Nyberg Surveying set a 1/2"x18" iron rebar on the centerline of 65th Avenue SW equal distance from the Northeast Corner of Section 7 and the Northeast Corner of Section 19. Corner position falls on old fences east and west.
