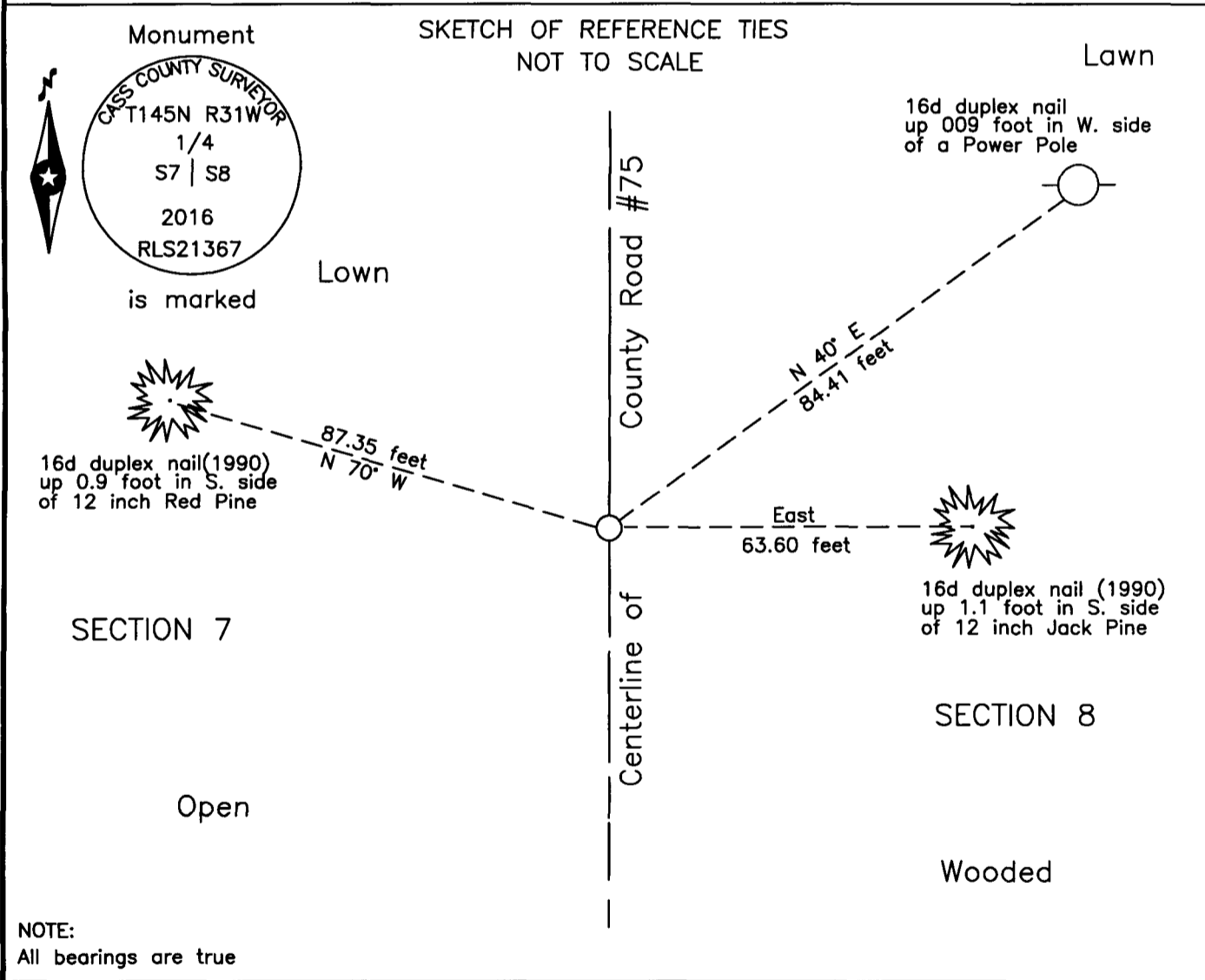

- Nov. 1982 G.H. Stevenson, LS 12684, Certificate of Survey for Johnson, copy on file in the CCHD/SO, Indicates iron monument found, at the subject corner.
- Aug. 1990 W.E. Curo, LS 11395, Certificate of Location of Government Corner, on file in the Cass County Recorders Office as Document #325739, Set a 2 inch telspar monument with aluminum cap, 1 foot East of centerline of County Road #75 and witnesses as follows:

- July 2016 B. Hippen, technician, records of the CCHD/SO, after construction of County Road #75, set an aluminum Cass County monument, in place of the recovered telspar post, down 0.05 foot, on new centerline of County Road #75.
