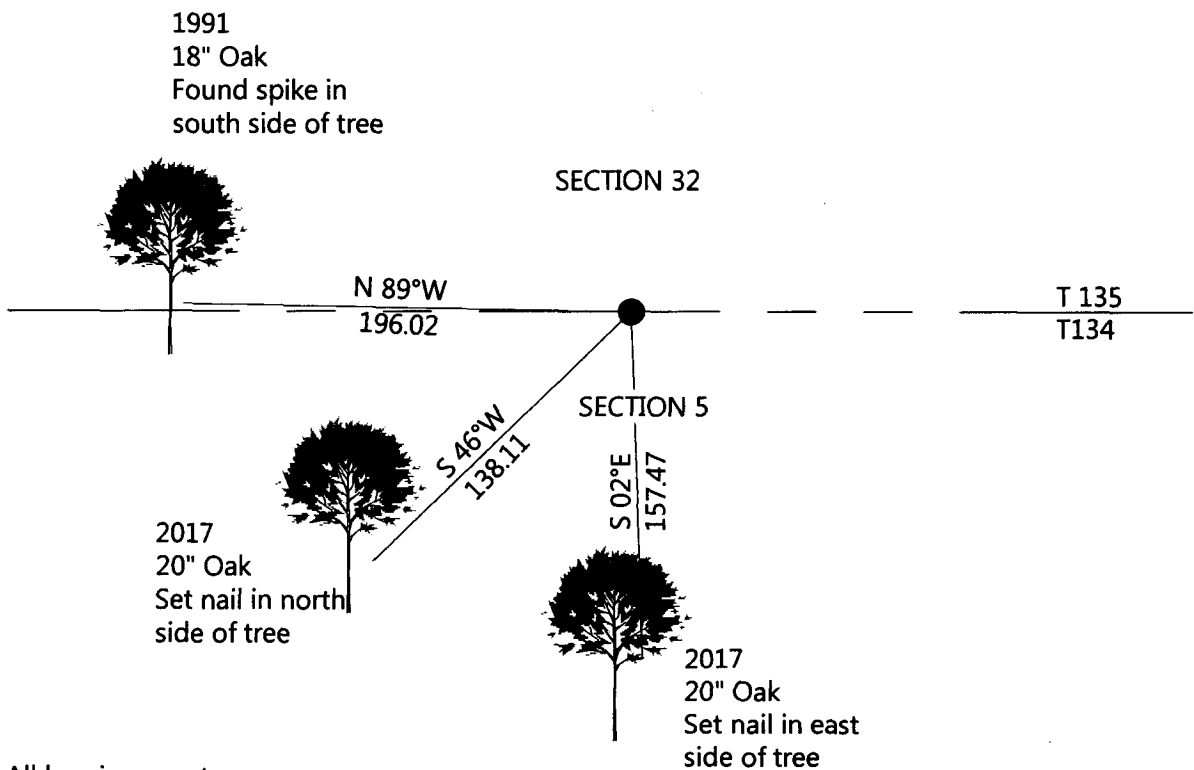
At the corner location shown on the sketch:

STATEMENT OF EVIDENCE**North Quarter Corner of Section 5, Township 134 North, Range 32 West of the 5th Principal Meridian.**

1858, Harvey Mellen, U.S. Deputy Surveyor, set a wood post to mark the corner location and established bearing trees as follows:

Tamarack	5"	N 67° W	50 links (33.00')
Tamarack	7"	S 57° W	46 links (30.36')

Record on file with the Minnesota Historical Society in St. Paul, MN and copies filed with the Cass County Highway Department, Surveyors Office (CCHD/SO).

1991 October, Thomas Thiessen, RLS 16097, from Cass County Land Corner Record, indicates no evidence of the post or bearing trees were found. He set a capped 1/2" iron pipe monument RLS 16097 at an obliterated position using a fence to the west and a creek call to the east and lists the following witnesses:

Unidentified tree	NW	196.23'
Unidentified tree	SW	128.40'
Unidentified tree	SE	144.02'

Filed a Certificate of Location of Government Corner on 11-24-92 and recorded as Doc. No. 343233. Information on file in the CCHD/SO.

1992 April, Thomas Thiessen, RLS 16097, filed a Certificate of survey which indicates he set the corner. Information on file in the CCHD/SO.

2007 February, Jarrett Leas, RLS 42619, filed a Certificate of survey which indicates the corner as found. Information on file in the CCHD/SO.

2017 March, a Northern Engineering & Consulting survey crew found a 3/4" iron pipe with no cap at the corner. They found and/or set witnesses as shown on the front of this certificate. I accept the found monument as a perpetuation of the original corner.
