## **Statement of Evidence**

## North quarter corner, Section 20, Township 138 North, Range 30 West, 5<sup>th</sup> Principal Meridian, Cass County, Minnesota

1865 – Wright and Walker, US Deputy Surveyors originally established this corner position while surveying the interior subdivision lines of Township 138 North, Range 30 West. A wood post was set to mark the corner position with the following witnesses:

20" N. Pine S 18° W 29 links 20" N. Pine N 58° E 36 links

Information on file in the MN Historical Society, St. Paul, MN. Copies on file in the Cass County Highway Department/Surveyors Office (CCHD/SO).

 2006 – Bruce W. Skipton, PLS 17768 shows monument in-place on Certificate of Survey dated June 7, 2006.
 Information on file in the CCHD/SO.

2018 – Patrick Trottier, RLS41002 finds a 2" iron pipe, 2' below grade and 3' east of the centerline of 42nd Ave SW and finds it conforming with prior section work. After analysis of record and survey information accepts this monument as the correct perpetuation of the corner and establishes the witnesses as shown on the face of this drawing.
