## Statement of Evidence

Northeast corner Section 27, Township 140 North, Range 25 West, 5th Principal Meridian.

Oct. O.E. Garrison, General Land Office(GLO) Deputy Surveyor in the notes of the subdivision of Township 140 North, Range 25 West, set a post for the original corner and referenced it as follows:

8" Tamarack N 78° W 7 links (4.62 feet) 5" Tam. N 32° E

8" Tamarack S 40 1/2° W 5 links (3.30 feet) 6" Tam. S 62° E 19 links (12.54 feet) Said records are on file with the Minnesota Historical Society, St. Paul, Minnesota, copies are filed with the Cass County Highway Department, Surveyor's Office (CCHD/SO).

Dec E.B. Horst, LS 376, Deputy County Surveyor, Survey Record 482, Book C, page 535, and Curo Book 68, page 3, 1915 on file in the CCHD/SO, states "I find cruisers cor. post and old line tree but no B.T."

Nov E.B. Horst, LS 376, Deputy County Surveyor, Survey Record 480, Book C, page 531, and Curo Book 68, page 51, on file in the CCHD/SO, states "Which I found on Jan. 1 1916, when I was cruising for sec. corners in Smoky Hollow Twp. At which time I found stake and stumps of 2 Tamck(sic) witness trees which were grubbed and thrown aside when building road which was not quite completed at that time. I blazed a 6" cedar on N. side of Road and a 10" Tamck(sic) on S. side of road at that time and also set the stake, made by Wattson, 25 ft. S. of

center of road which a Mr. Laughlin identified and told me where to find." He lists B.T.s as follows".

10" Tamck
S. 23.4 feet 6" Cedar N. 17 feet

May Smoky Hollow Township Road Order, on file in the CCHD/SO, Surveyors Report indicates road on the section line.

Aug. J.W. Curo, LS 1428, Curo Book 152, page 55, on file in the CCHD/SO, pictorial indicates North line of Section 26 at 5297 and lists the 1920 witnesses.

1937 CCC personnel, Washburn Lake notes, Book 3, page 18, on file in the Department of Natural Resources Office (DNR), states at 5280 from west set approx. corner.

Jan. B. Hippen, technician, records of the CCHD/SO, set a 1 1/8 inch outside diameter iron pipe, RLS 16459, down 0.2 foot, on centerline of old road grade at the 1924 distance from the NE corner of Section 26 and the following witnesses:

8" Maple N 24° E 53.50 feet 10" Tamarack S 30° E 52.75 feet 8" Ash S 70° W 59.27 feet 10" Balsam N 50° W 58.55 feet

The monument, recovered and established references for the position are shown on the face of this document.

Analysis of the recovered record data, field evidence and survey measurements, indicates that the monument set by the CCHD/SO in 2006 is the accepted location of this corner.
