ROAD PETITION

To the Supervisors of the Town of Wynne in the County of Call
and State of Minnesota:

The undersigned, legal voters who own real estate, or who occupy real estate under the Homestead or Pre-emption Laws of the United States or under contract from the State of Minnesota, within two miles * three miles

of the road to be laid out hereby petition you to

lay out a new road as follows: Beginning at the north east corner of sec five (5) town one hundred and thirty five (135) range thirty two (32), running west on the north line of said town to a point eighty rods west of the north east corner of sec six (6), thence south eighty rods thence west as near as practicable to a point about eighty rods south of the north west corner of said sec six (6)

The description of the lands over which the said proposed road passes and the names of the owners thereof, which are known, as well as the lands the names of whose owners are unknown, are as follows:
