ROAD PETITION.

To the Supervisors of the Town of Ansel, in the County of Cass and State of Minnesota:

The undersigned, legal voters of said Town, who own real estate or who occupy real estate under the Homestead or Pre-emption Laws of the United States, or under contract with the State of Minnesota, within three miles of the road proposed to be established, hereby petition you to establish a new road as follows:
