Whereas, a road was laid out on the 30th day of May, A. D., 1911, by us, the supervisors of the said town of Pine River, on the petition of eight legal voters who own real estate, or occupy real estate under the homestead of pre-emption laws of the United States, or under contract from the state of Minnesota, within three miles of said road; which said road is set forth and described in the foregoing supervisors' road order made by us. And whereas, a part of the damages sustained by reason of the laying out of said road has been ascertained by the agreement of the owners of lands through which said road passes; but not being able to agree with the owners of the following described lands, claiming damages by reason of said highway passing through, we have assessed the damages to each of such individual claimants with whom we could not agree; taking into account and estimating the benefits the road will confer on the claimants and owners, as well as the disadvantages. We have assessed and awarded damages as follows:

SUPERVISORS ORDER OR NOTICE OF HEARING.

NOTICE IS HEREBY GIVEN That the supervisors of the town of Pine River, in the county of Cass, and state of Minnesota, will meet on the 20th day of May, A. D., 1911, at two o'clock in the afternoon, at the northeast corner of the Southwest quarter of Section Thirty-one, Township 138, Range 29, in said town and county, for the purpose of personally examining the route named below, proposed for a new road, and for hearing all reasons for or against said proposed laying out, and to act upon said petition. Said proposed new road as described in the petition is as follows:

Beginning at a point twenty-two rods east of the Northeast corner of the Southwest quarter of Section 51, Township 138 North, Range 29 West of the 5th P. M. in said county, running thence north parallel with the west line of the Northeast quarter of said Section Thirtyone a distance of 80 rods to the south line of said Northwest quarter of the Northeast quarter of said Section Thirty-one, at a point thereon twenty-two rods east of the northeast corner of the Southeast quarter of the Northwest quarter of said Section 51.
