

ROAD PETITION

To the ~~Supervisors of the Town of~~ **C. Commissioner**

and State of Minnesota: In the County of **Cass**

The undersigned, legal voters of said Town, who own real estate, or who occupy real estate under the Homestead or Pre-emption Laws of the United States, or under contract with the State of Minnesota, within three miles of the road proposed to be **graded** herein petition you to

grade the road as follows: **Beginning** Here should follow a general description of the road, showing its point of beginning, general course and termination, and what part is to be altered or vacated, if an established road.

Beginning at the northeast corner of Section 25, thence running due south 4 miles to south west corner of section 24 they cut on half mile, they then south then section 25 they on south then section 36 to highway 371
